









# Improvement Resource Collaborative

## **BACKGROUND**

The Improvement Resource Collaborative was formed by the Auckland Region District Health Boards (Auckland, Counties Manukau, and Waitemata) and the Health Quality and Safety Commission, with the goal of creating some consistency in how Quality Improvement is conducted across healthcare settings in New Zealand. This tool kit would be a free resource available to all and its use would not be mandated.

# **METHOD**

156 people with healthcare improvement experience across New Zealand were surveyed to determine the value and usability of the tool kit, as well as to make the tool kit reflect our collective expertise. Survey participants were asked if they used 13 specific QI tools and if they had a template to share.

# RESULTS

# **Tools Used / Not Used:**

51 responses – 33%


